Overview

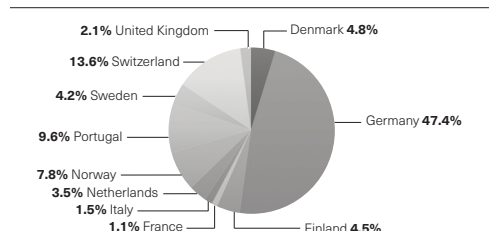
- The Blackwall Europe Equity Fund follows a fundamental, value-based equity strategy.
- Investments are made in fundamentally mispriced European stocks often of mid-sized, under-researched companies.
- The objective is long-term capital appreciation by outperforming the market.
- Unconventional thinking is key to achieving superior returns. We only invest in companies which we fully understand with an ideal investment horizon of about 3-5 years.
- Managing and understanding risk is a fundamental aspect of the investment strategy. Risk is further mitigated by applying a margin of safety.
- The Fund is managed by Blackwall Capital Investment AG (Zug/Switzerland), which was founded by Thomas Karlovits, the former head of European Equity Research at Kepler Cheuvreux.

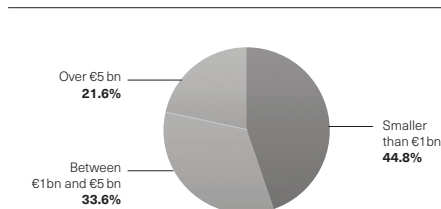

Country Breakdown



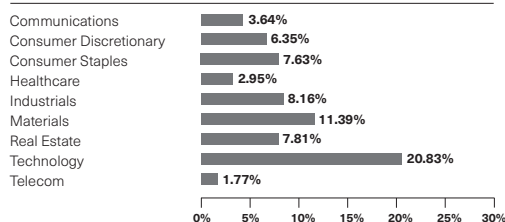
All at 29 February 2020. Country Breakdown as % of equity holdings

All at 29 February 2020. Market Capitalisation Breakdown as % of equity holdings

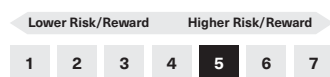
Sector Exposure
